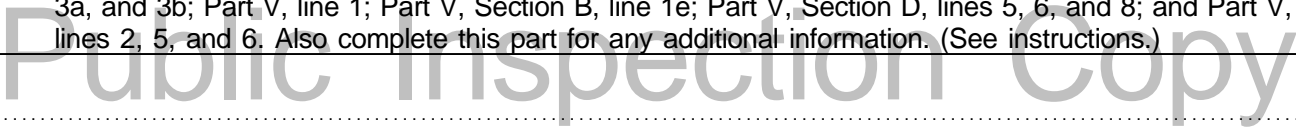

Throughout the year we successfully maintained 40 water projects throughout Ghana, Africa's Eastern Region. We then completed 14 new water projects. In total, we now have 54 water projects serving over 55,000 people in Ghana with safe access to clean water.
